### **1. Apologies for Absence.**

### **2. Proposal for the filling of the casual vacancy of Parish Councillor to West Crewkerne Parish Council by Co-opting Mr O Pyle-Santini to the post of Parish Councillor.**

The Clerk had received an application for the vacant Parish Councillor position on West Crewkerne Parish Council from Mr O Pyle-Santini and as there were no other applicants the clerk asked for a proposer and seconder and a show of hands from the Parish Councillors present as to whether they accept Mr O Pyle-Santini application to be co-opted on to the West Crewkerne Parish Council. Mr D Yeomans proposed that Mr O Pyle-Santini be co-opted on to West Crewkerne Parish Council and Mr F Freeman seconded the proposal and all the Parish Councillors were unanimous in accepting the proposal. Therefore Mr O Pyle-Santini has been formally co-opted on to the West Crewkerne Parish Council.

## 7. Highway Matters

Mrs C Broom (Parish Councillor) stated that the tarmac is missing on the highway that butts up to the drive of their house and it looks like the drain has collapsed. Mrs C Broom has reported this to Somerset Highways but without success. Mr M Best (Somerset County Councillor) asked Mrs C Broom to send him photographs of the damaged area and he will take it up with the Highways department. The clerk stated that she would also contact Somerset Highways via their website.

Mr Mike Best also stated that the Small Improvements Scheme team are taking measurements at the Cathole Bridge Road cross-roads. The new Parish Councillor Mr O Pyle-Santini was made aware of the developments that maybe taking place on the Cathole Bridge Road cross-roads.

## 8. Roundham

The Clerk had heard nothing from Somerset County Council complaints department regarding the complaint she had lodge with them. The clerk will follow up the complaint.

Mr D Yeomans stated that the white lines had been drawn on the road in Roundham. Mr D Yeomans suggested canvassing the Residents of Roundham to ascertain from them whether they considered that, the Small Improvement Scheme has made any significant difference to the speed of the traffic. Mr D Yeomans made this proposal which was accepted by the other Parish Councillors present. However Mr D Yeomans felt that before we canvassed the residents of Roundham we should wait

until the scheme is fully finished. Mr D Yeomans asked the clerk to note the proposal but to put it on hold for the time being.

9. Reports from Councillors, including District and County Councillors.

There were no reports from any of the Parish Councillors.

Mr M Best (Somerset County Councillor) stated that elections would take place next May 2022 for the new Unitary Councillors who will replace the present Somerset County Councillors and the District Councillors will cease to exist May 2023.

Mrs S Osborne (South Somerset District Councillor) stated that they were looking at Boundary wards. Mrs S Osborne had emailed out to the clerk a copy of ward areas and numbers, which the clerk had emailed to out to all the Parish Councillors, please let Mrs S Osborne have any remarks on the contents of the email. The Boundary Commission review takes place in 2023. There is a feeling that with the Unitary Council that any elected Councillors will be career Councillors because the size of the wards or areas they will have to manage will exclude anybody who has other employment or interests. The deadline for claiming any monies from the South Somerset District Council's Covid Fund is end of March 2022. The District Council is also looking at a new electricity supplier. The budget for South Somerset District Council is mid-term and is on track. Mrs S Osborne stated that everybody still needs to be vigilant with regard to the Coronavirus as the virus is still prevalent. South Somerset District Council staff team members are also going to be involved in the transition of information and material over to the Unitary Authority which is going to put even greater strain on the resources of the South Somerset District Council.
