14,000 incidents of fraud are reported each day, £7 billion has been lost to individuals, fraud made up 42% of all crime reported in the last 12 months, 70% of fraud is via the telephone, fraud is not only about money it is also about obtaining your personal data.

The Golden rules to avoid fraud are as follows:

If it sounds too good to be true it probably is, for instance if you are told you have won in a lottery you never entered don't pay a fee to collect the winnings. Be careful if you are being time pressured. Don't pay in crypto currency or bitcoin. Don't put large amounts on gift cards or vouchers. Never give out your personal data. If in doubt ask for advice from a relative or friend, or phone the police on 101. Rely on your instincts and don't be pressured.
