128 Members to review Crewkerne Town Council’s precept request for the Townsend Cemetery

This year’s precept request came in much lower at £295 due to a refund from the 2022-2023 precept. Crewkerne Town Council are now using the Lodge Building as an office and are therefore now responsible for all costs appertaining to the Lodge. The draft 2024-2025 precept will be discussed at the Joint Committee meeting in October and will be brought to WCPC November meeting.

129 Report from the Joint Burial Committee

Cllr Borland reported; over the past few weeks the Internal works have been completed in the lodge building. This is now a functioning office and work space for some of the town council staff. Within the cemetery the grass is being mown within both the older and newer sections. As usual the weather does have its challenges, not only does the grass grow quickly but so do the weeds. By now all seasonal wreaths should have been removed from graves, and there are dedicated bins for their disposal. However, it should be noted that there are some still in place and are in the process of being removed. Ther very large monkey puzzler tree at the far end of the cemetery is shedding some of its branches, and as some have, and are likely to fall onto the path in this area any that are loose will be safety removed, by means of a cherry picker. Regular walks throughout the whole of the cemetery by the town clerk, chair and vice-chair and the contractors are in place.

Details of a 3-day road closure at the Cathole Bridge Crossroads were discussed. The only detail on the Council Highways website stated that this was due to necessary work in the middle of the road. No details were sent to the parish council in advance of this closure.
