194 Report from the Joint Burial Committee

Cllr Borland reported Councillor Frank Freeman passed away in January and our sincere condolences were sent to his wife. He had been a very valued member of West Crewkerne Parish Council and the Joint Burial Committee for a number of years. West Crewkerne therefore have a vacancy for a member of this committee. There are three areas within the cemetery which are needing attention. The stone pillar at the entrance gates has been damaged by an unknown vehicle. Apparently, it is common that vehicles use this area to reverse and turn in. The cost of repair will be claimed for under insurance. The southern boundary of the cemetery wall at the right-hand side of the entrance gate has been needing maintenance for some time. Rocks have been falling onto the adjacent right of way. As such they are a trip hazard. The large Holm Oak has a large split down the middle. Basically the cable braces are doing their job but need urgent inspection and possibly an upgrade, along with the removal/reduction of a substantial bough (poss. 2-3 tonnes in weight!) which would come down across the path of multiple graves if it failed.
