## 266 Report from the Joint Burial Committee

The following report was provided by Julia Borland, Vice Chair Joint Burial Committee

The cemetery is subject to vagaries of the weather and during the past fortnight the snow, albeit only being around for a couple of days, weighed heavily on two branches of the large healthy Cedar tree causing two of the limbs to break. These have now been removed. However, Storm Bert with its very strong winds and heavy rain would appear to have had no adverse effect. At the September meeting quotes were discussed and agreed for path improvements. This work would be fully covered by the earmarked reserves for cemetery paths. Also discussed was the cemetery maintenance contract for 2025. Progress towards the unveiling of the Spitfire memorial plaque in March 2025 is nearing completion. There would be a short daytime ceremony followed by refreshments; this will be to coincide with the visit of the pilot F D Schofield's son to the UK. At a recent tour of the cemetery grounds, it was noted that there seemed to be proliferous memorial benches throughout the grounds. Some appear to have been placed there without any discussion or agreement. A policy is in the process of being drafted for memorial benches and trees. The next meeting of the Joint Committee is on Tuesday 3rd December at 18.45pm in the Town Council Chamber.

#### 267 Highways Matters and Flooding Issues

The cause of increased instances of flooding along the Cathole Bridge Road to Roundham was discussed in full as were the gullies and drains from Hewish crossroads through to the junction of Dunsham Lane with Clapton. Several suggestions were made on how to alleviate the flooding including; writing to the land owner asking them to clear ditches, paying for an additional drain and gully cleaning (if funds allow) and speaking to the Environment Agency about making improvements to the river
