## 324 Report from the Joint Burial Committee - May 2025

On June 3rd 2025 at 7pm the Joint Burial Committee will hold its Annual meeting in the Chapel at Townsend Cemetery. This will have been proceeded by a walk around the grounds by all attending members of the Joint Committee. Discussions will take place during this process to note the effectiveness of the trial replacement of the old section of the cemetery pathways. This will be the opportunity to review the way in which the cemetery has been managed for the past year, and make recommendations for the forthcoming year. As usual it should be noted that the weather will dictate some of the challenges. The grass cutting especially during periods of very wet weather is difficult to achieve, but if this is followed by a long period of dry weather the grass will grow, and therefore require cutting quickly. We are fortunate to work with contractors who understand and support the cemetery requirements. The Annual meeting will receive a report from retiring Chairman and then elect a Chairman and Vice Chairman for the next year. ### 325 Highways Matters and Flooding Issues including an update from the meeting with Highways

Cllr Borland and the Clerk reported on their meeting with Highways. The worst roads for flooding in the parish are the section from Woolminstone lane to Dunsham lane and along Cathole Bridge Road. The contractors were unable to lift the manhole cover on Cathole Bridge Road and had been archived. This has now been fixed and is awaiting jetting. The sustainability of the bank on Cathole Bridge Road was discussed. Ann Bulls Grave Road potholes were also discussed as some of these have been filled.

An email has been received from Beaminster TC regarding their Community Bus Service. They are asking if we consider there would be any interest from residents for a Saturday Bus Service from Crewkerne to Beaminster via Clapton. There is already a Saturday bus service from Clapton to Crewkerne.
